#### **CSEA Chapter Register Legend**

Your CSEA Chapter Register is produced during the last week of each month, and contains a list of members whose membership applications have been keyed into the database or transferred to your chapter before CSEA's month-end closing. (Cut-off time is usually the Friday proceeding the last week of the month.)

Dues amounts and payment status listed on the register is current as of the first of the month.

#### Report columns defined

Column name	Description of data
NAME	Member's name (in format Last, First Middle).
ID#	CSEA membership ID number. An internal number generated in CSEA's database that uniquely identifies the member.
Sub	Sub-chapter. Always blank. Used by Local 1000 Chapters to divide their members into smaller groups. CSUEU does not implement sub-chapters.
BU	CSEA bargaining unit identifier. To find the CSU bargaining unit number, remove the leading 3. (Example: 39 = CSU Unit 9.)
TPS	Type/Payment/Status. Decode using the key below.
Amount	Amount of membership dues received this month. For dues collected by payroll deduction, the State Controller deducted this amount from the employee's warrant during the last pay period, and paid CSUEU this amount on the first of this month.
YTD	Sum of dues received during this calendar year.
Bad Add	Bad address. If the letter "Y" appears here, then the U.S. Postal Service has returned as undeliverable at least one piece of mail addressed to this member. The member's address may no longer be current, and CSEA may no longer be able to send mailings to this address.
Address	Member's address as shown on CSEA's records. Typically originates from the membership application.

Codes 2 through 4 indicate the member is paying dues directly to CSEA.

#### S Payment status

- 0 Current
- 1 30 days delinquent
- 2 60 days delinquent
- 3 Suspended (90+ days delinquent)
- 4 Former members

Example: A10 = A civil service member with current dues. C13 = A CSU member without a dues payment within the last 90 or more days.

#### **Decoding the RMKS column**

#### **Application Date**

mmyyyy	A string of numbers indicates the member's application date, in the format MMYYYY or MYYYY (MM=1 or 2-digit month number, YYYY=4-digit year). Example: 41996 = member joined in March, 1996.

#### Record transactions occurring

ADCH	A home address change transaction occurred.
CANC	A membership cancellation transaction occurred.
NAME	A name change transaction occurred. The name listed is the new name.
NEW	The member was added as a new member.
SS#	A social security number change transaction occurred.

#### Job changes

JI nn	Job became Inactive during the two-digit month listed.
JO nn	Member On Leave from job during two-digit month listed.

#### Members transferring between CSEA chapters/DLCs

Fnnn	The member transferred from the chapter/DLC specified (i.e. F511 = transferred from chapter 511 to your chapter).
Tnnn	The member transferred to the chapter/DLC specified (i.e. T721 = transferred from your chapter to DLC 721).

#### Membership status changes

A nn	Membership status changed to <b>Active</b> during the two-digit month listed.
B nn	Membership status changed to <b>Active (Pay Direct)</b> during the two-digit month listed. (The member is paying dues to CSEA directly, instead of payroll deduction.)
C nn	Membership status changed to <b>Courtesy</b> during the two-digit month listed.
D nn	Membership status changed to <b>Deceased</b> during the two-digit month listed.
DEL nn	Membership status changed to <b>Deleted</b> during the two-digit month listed.
I nn	Membership status changed to <b>Inactive</b> during the two-digit month listed.
L nn	Membership status changed to <b>Leave/Absence</b> during the two-digit month listed.
P nn	Membership status changed to <b>Punitive Suspension</b> during the two-digit month listed.
R nn	Membership status changed to <b>Retired</b> during the two-digit month listed.
S nn	Membership status changed to <b>Separated</b> during the two-digit month listed.
T nn	Membership status changed to <b>Terminated</b> during the two-digit month listed.
